Gilpin County Community Center Teen After School Code of Conduct Guidelines

1. Immediately upon entering the Community Center, youth must check in on the Teen After School Roster.
2. Food, drink, and glass must be kept in the designated areas (upstairs lobby, multi-purpose room). Food and drink are not allowed in the pool area, gym, track, weight room, cardio hall, or the pottery studio. Water bottles only are permissible in these areas.
3. Smoking, vaping, drinking alcohol, chewing tobacco, and gum are prohibited everywhere in the facility and grounds, with the exception of designated smoking/vaping areas outside. Any minors witnessed using regulated substances will be reported to police.
4. Profanity, verbal or physical altercations, bullying, roughhousing, inappropriate touching, prolonged displays of affection, vandalism, and weapons are strictly prohibited in the facility, and may result in consequences, up to immediate expulsion from the facility.
5. Areas of participation within the facility include the multi-purpose room, gymnasium, and pool.
6. Outside, youth may use the trail and BMX track. Other areas may only be used with explicit permission.
7. Use of the weight room and fitness hall are allowed for individuals aged 14 and over. All minors must receive a free fitness and equipment orientation from Community Center staff before using these areas.
8. Respect for the staff, facility, and other guests is expected at all times. Any guests determined to be routinely inconsiderate of other guests, staff, property, and/or equipment may be suspended or expelled from the facility.
9. Repeated violation of the above guidelines, or lack of compliance with any staff request could result in suspension or expulsion from the facility. Further repeat offenders may result in trespassing summons being issued.
